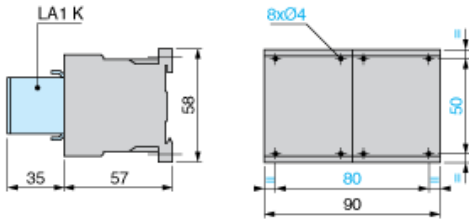

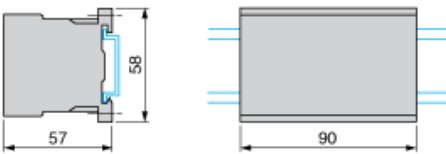

Reversing Contactors LC 2 K, LP2 K, LP5 K: Mounting on Panel

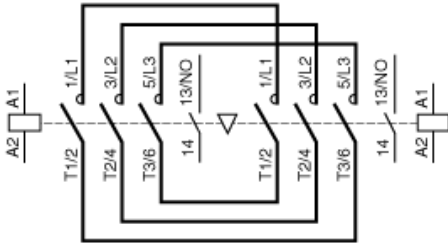


Reversing Contactors LC 2 K, LP2 K, LP5 K: Mounting on Rail AM1 DP200 or AM1 DE200 (35 mm)
